Funds raised go to put on the event including entertainment, prizes, free games for children, judges, etc. Gross Receipts were \$ 82,404 expenses for \$24,821 and \$57,583 was donated to AWARE Central Texas, a local non-profit that helps with the prevention of child abuse. The fund raising team for this event is made up of volunteers and they do not get paid or take a percentage of the revenues. Those who volunteer receive a T-Shirt and/or a hat.

NOTE: We partner with this organization because we realize that the two most common reasons for Veterans to become involved in the Criminal Justice System is Drug Abuse, Misuse and Addiction and Domestic Violence which includes Child Abuse. This fits our mission.

Lights & Sirens = we are the fiscal sponsor. The funds raised were in September 2016 and carried over plus additional funds were raised. We then distributed \$22,000 in October to several Police & Fire charities. Additionally \$903 went to Hurricane Harvey Relief. \$500 went to KPLE TV. Retained \$1179 for future donations.
